In-Person COVID-19 Safety Protocols

WellSky is committed to the health and safety of our attendees. Accordingly, WellSky has implemented the following COVID-19 safety protocols:

Vaccine Certification

All attendees must be fully vaccinated against COVID-19 by the event date. To be considered *fully vaccinated*, you must have received a two-dose series of an mRNA COVID-19 vaccine (Pfizer-BioNTech or Moderna) or a single-dose COVID-19 vaccine (Johnson & Johnson's Janssen vaccine) by January 22, 2022.

Onsite registration & COVID-19 testing

All attendees must participate in on-site rapid testing and receive a negative COVID-19 test result prior to attending the event. Upon arrival to the Biltmore Arizona hotel, please look for the WellSky event registration area in the main foyer. Registration and COVID-19 rapid testing will be available during the following dates/hours:

- **Saturday, February 5th** 11:00am - 6:00pm at the Biltmore Arizona hotel
- **Saturday, February 5th** 5:00pm - 6:30 pm at Christopher's restaurant

You are encouraged to schedule a specific testing time and complete necessary registration prior to arrival. Please look for an email by Monday, January 31 to schedule your test.

Attendees who receive a positive test result will be required to immediately isolate themselves in accordance with applicable [CDC Quarantine and Isolation Guidelines](#), as well as any other state or local regulatory guidelines. The Biltmore Arizona has rooms available for individuals who decide to shelter in place, and WellSky will cover the cost of the room as needed.

All attendees will be asked to complete a COVID-19 Safety Acknowledgment form at registration. The form is provided on the following page for your review.

Face masks

WellSky will continue to closely monitor developments related to its COVID-19 protocols, along with applicable regulatory recommendations and requirements, and will adjust its safety measures (e.g., the use of face masks for the indoor events) to provide a safe environment. Currently, Maricopa County and the CDC recommend people wear a mask while indoors regardless of vaccination status.

COVID-19 SAFETY ACKNOWLEDGMENT

While attending the WellSky Corporation (“WellSky”) HC100 VIP dinner and event on February 5, 2022 (“the Activity”), unless otherwise exempt, I agree to abide by the applicable CDC guidance and health orders of Phoenix, and/or Maricopa County to reduce the risks of exposure to COVID-19. Because COVID-19 is extremely contagious and is spread mainly from person-to-person contact, I acknowledge that WellSky has implemented preventative measures to reduce the spread of COVID-19, agree to adhere to such preventative measures, and that WellSky cannot guarantee that its participants, partners, or others in attendance will not become infected with COVID-19.

I certify that I do not fall into either of the following categories:

1. Individuals who currently or within the past ten (10) days have experienced any symptoms associated with COVID-19, which include fever, cough, loss of taste/smell, and shortness of breath, among others (“Covid Symptoms”);
2. Individuals who believe that they may have been exposed to a confirmed or suspected case of COVID-19 or have been diagnosed with COVID-19 and are not yet cleared as non-contagious by federal, state, or local public health authorities or the health care team responsible for their treatment.

DUTY TO SELF-MONITOR: I agree to self-monitor for Covid Symptoms and, as appropriate, discontinue my participation immediately if I experience any Covid Symptoms during the Activity and/or contact WellSky at covid19support@wellsky.com if I experience Covid Symptoms within 5 days of participating in the Activity.
