Enables a user to display or change the status of an implantable device.	
§ 170.315(b)(10) Electronic Health Information Export	Enables an authorized user to generate an Electronic Health Information Export in an electronic and computable format for a single patient when requested. Population EHI export can be generated in an electronic and computable format with assistance from WellSky.	
§ 170.315(d)(1) Authentication, Access Control, Authorization	Enables unique user identification and authentication against unique identifiers (e.g., username/password) before providing access to electronic health information and includes the ability to control the specific access and privilege rights a user is granted.	Required costs include software licenses for WellSky Specialty Care solution per standard contracting terms.

§ 170.315(d)(4) Amendments	Authorized users can document patient requests for amendments when the amendment is accepted and when denied.	
§ 170.315(d)(5) Automatic Access Time-out	WellSky Specialty Care automatically stops a user's access after a period of inactivity. A user is required to re-enter their credentials to regain access.
